Nationa Audit of

Breast Cancer in Older Patients

NHS England and the Welsh Government are in the process of commissioning a number of new national cancer audit topics, to be delivered by a new National Cancer Audit Collaborating Centre. This will include an audit of primary breast cancer, and an audit of metastatic (secondary) breast cancer.

These two breast cancer audits would cover women and men of all ages. The Collaborating Centre is expected to open in Autumn 2022. The NABCOP will work with HQIP during 2022 to ensure an effective and smooth transition to the future breast cancer audit programme. For more information, please see the HQIP website.

Completeness of data items

The two national breast cancer audits will rely on national cancer registration data and so it is vital to continue to improve data completeness. We ask you to focus on the data items for triple diagnostic assessment and the items on patient fitness. Information on how to improve data completeness can be found on the NABCOP website.
